**RESUME OF WORK TRANSACTED BY THE TAMIL NADU LEGISLATIVE
ASSEMBLY FROM 26th FEBRUARY 1982 TO 7th APRIL 1982**

I. DURATION OF THE MEETING

The Second Meeting of the Fourth Session of the Seventh Legislative Assembly commenced on the 26th February 1982 and the House was adjourned *sine die* on the 7th April 1982.

II. PROROGATION

The Fourth Session of the Seventh Legislative Assembly was prorogued with effect from 10th May, 1982.

III. ACTUAL DAYS OF SITTINGS OF THE ASSEMBLY

The Legislative Assembly met for 32 days during the period from 26th February 1982 to 7th April 1982 on the following dates:-

26th February 1982; 1st to 6th ; 8th to 13th; 15th to 20th 22nd to 25th, 27th and from 29th to 31st March 1982, 1st, 3rd, 5th and 7th April 1982.

It also met in the evening for 10 days on the following dates;

5th; 8th; 11th; 13th; 16th to 19th; 24th and 27th March 1982.

In terms of hours, the House sat for 178 hours and 36 minutes.

Voting on Demands lasted for 17days from 8th March 1982 to 29th March 1982.

29th March 1982 was fixed as the last day for discussion on the Demands for Grants after which the following demands were guillotined and put and carried without discussion:-

Out of 3,319 Cut Motions received, 3,100 were admitted of which 51 were moved and they were withdrawn or deemed to have been withdrawn.

The Appropriation Bill relating to the Budget was introduced in the Assembly on the 29th March 1982 and it was taken for consideration on the 30th March 1982, and it was passed on the same day on 30th March 1982.

On the 22nd March 1982, Hon. Minister for Finance presented the Final Supplementary Statement for the year 1981-82. On the 25th March 1982 the demands for Grants were put to vote and carried. The Appropriation Bill relating to the Final Supplementary Statements was introduced on the 25th March 1982 and was considered and passed on the 27th March 1982.

XIII. LEGISLATIVE BUSINESS

During the period 21 Bills were introduced of which 18 Bills were considered and passed and 2 Bills were referred to Joint Select Committee and one Bill is pending.

And whereas it appears to this Assembly to be desirable that the matters set out below in so far as they relate to estate duty in respect of agricultural land should be regulated in the State of Tamil Nadu by Parliament by law and for this purpose the aforesaid Act should be amended:-

- (i) raising the exemption limit for estate duty from Rs. 50,000 to Rs. 1,50,000 and providing for the rate of estate duty at 10 percent of the first slab of estate range of Rs. 1,50,000 to Rs. 2,00,000;
- (ii) Providing that a member of a Co-operative Housing Society to whom a building or part thereof is allotted or leased under a house building scheme of the society shall be deemed to be the owner of the building or part thereof:

- (iii) Valuation of one residential house or part thereof belonging to the deceased would be made on the same basis as under the Wealth Tax Act, 1957 (Central Act 27 of 1957)

Now, therefore, in pursuance of Article 252 of the Constitution, this Assembly hereby resolves that the Estate Duty Act, 1953 (Central Act 34 of 1953) may be amended by Parliament to provide for the aforesaid matters with effect from the 1st day of March 1981.

Hon. Minister for Revenue replied to the debate.

The resolution was adopted.
